

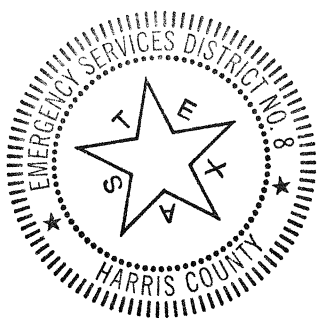
NOTICE OF PUBLIC MEETING

The District will consider and act upon the following matters:

1. Call meeting to order.
2. Roll Call and establishment of a quorum.
3. Recite the Pledge of Allegiance.
4. To receive public comment.
5. To approve minutes from prior meeting(s).
6. To review, discuss and take action regarding retention of new District Bookkeeper.
7. To review and act on financial matters, including review and analyses of financial reports, payment of District bills, including investments, depositories and other accounts, audits, and Investment Policy.
8. To receive a report from the Executive Director.
9. To review, discuss and act on adjustments to the District's insurance policies, including automobile liability, professional liability, workers compensation and health benefits.
10. To review and act on the acquisition of apparatus, equipment, tools, technology, and supplies, including financing of same.
11. To approve maintenance, repairs and modification of real and personal property.
12. To review, discuss and act on any issues related to the construction, repairs, maintenance, or improvement of District facilities, including engaging architect and construction services.
13. To approve the disposition of property, including surplus and/or salvage property.
14. To receive an update regarding the status of the FEMA PA Grant application for public assistance disaster funding from Winter Storm Uri.
15. To review, discuss and act on the need for temporary facility space.
16. To review, discuss, and take action on an agreement with Stryker for service on existing equipment.
17. To review discuss and act on matters related to transitioning to a direct provider model, including personnel matters, apparatus and equipment acquisitions, policies and procedures and employee benefits.
18. To review, discuss and take action regarding a Memorandum of Understanding amongst Harris County First Responders regarding Active Shooter and Hostile Event incidents.

19. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
20. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
21. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
22. To schedule the October 2022 meeting.
